

Forest Law Enforcement, Governance and Trade

We are in a climate and biodiversity emergency.

In just 40 years, a forest area the size of Europe has gone from a variety of pressures, primarily in the tropical world, accentuating the climate crisis and destroying habitats.

Growing populations place greater pressure on forests, and an economic incentive to convert to agriculture.

FLEGT, stands for Forest Law Enforcement, Governance and Trade. This global project aims to use market forces to strengthen sustainable forestry practices.

By growing the market for sustainable timber, we can help keep our forests standing.




UK TTF FLEGT Communications

The TTF promotes the FLEGT Action Plan as a way to improve conditions in the forest and throughout the tropical supply chain; as a legal and verified way to import and specify tropical timber; to gain inclusion for tropical species in procurement policies for designers, architects and others.

Our pan-European FLEGT communications drive aims to raise the market profile of the initiative and awareness of the wider impacts of countries undertaking progress VPAs with the EU/UK.

We also use this as a vehicle to raise awareness about governance, certification and sustainability issues more generally within global forests.

2021 - 2022 Projects

The UK TTF focuses on nine project areas: the UK, Europe, Indonesia, Ghana, China, Vietnam, Gabon and COP26.

- We work with retailers and end-users to educate them to the benefits of specifying FLEGT-licensed goods and inclusion within their procurement policies.
- Enhancing communications to promote FLEGT to specifiers and producers around the world
- Development of materials and documents for associations on FLEGT, responsible sourcing and due diligence
- Additional e-learning modules for national associations on FLEGT, sustainable forest management and timber legality/ sustainability
- Changing the profile of tropical hardwoods and promotion of FLEGT values in widely-accessed media




TTF Promotion




